

Sureform® Super 10 Year Warranty

Sureform® Super is a composite roof flashing material manufactured and sold in Australia by CA Group (Australasia) Pty Ltd (Consolidated Alloys).

Sureform® Super will remain watertight in use and is suitable as a roof flashing material.

Sureform® Super meets the requirements of the following industry standards:

1. AS/NZS 4347: PART 4 (determination of water permeability).
2. AS/NZS 2904 (damp-proof courses and flashings).
3. AS/NZ 4020:2005 (Australian drinking water standards).

Warranty

1. CA Group warrants to end users that all Sureform® Super products will be free from defects in material and workmanship for 10 years, commencing from the date of manufacture.

To be valid, any warranty claim with regard to any defect in a Sureform® Super product must be made in writing by the claimant to CA Group (32 Industrial Ave, Thomastown, VIC 3074) within 30 days following discovery of the defect. [A tax invoice or receipt as proof of purchase is required.]

2. This warranty shall not apply where:
 - (a) the Sureform® Super product has not been installed in line with the CA Group installation instructions (which can be downloaded from www.cagroup.com.au) and has not been properly maintained.
 - (b) the Sureform® Super product has been used for any purpose other than in roof flashing applications in accordance with the relevant Building Codes of Australia.
 - (c) defects in the Sureform® Super product are a result of an act of god, including but not limited to, weather events for which flashing generally would not provide a suitable protection.
 - (d) the Sureform® Super product has been damaged after supply by CA Group or as a result of the negligence or misuse of the Sureform® Super product by the claimant or any third party.

Territory

This warranty only applies to installation within Australia.

Limitation and exclusion on liability

The liability of CA Group for any claim under this warranty is limited to the value of Sureform® Super products supplied for which there is a valid warranty claim.

CA Group will not be liable under this warranty for any indirect, special, economic or consequential loss or damage (including without limitation loss of revenue, profits, goodwill or opportunities) arising out of or in connection with, the supply of Sureform® Super products whether caused by the negligence of CA Group or otherwise and whether or not CA Group was aware, or should have been aware, of the possibility of such loss or damage.

To the extent permitted by law, this warranty is given in lieu of all other warranties and guarantees, express or implied, including any warranty of merchantability or fitness for a particular purpose.

To the extent that these terms cannot by law operate to exclude the liability of CA Group for any claim, loss or damage, defect, expense or injury, the liability of CA Group arising from or in connection with Sureform® Super products is, to the full extent permitted by law, limited, at the election of CA Group, either to:

- (a) the replacement of the affected Sureform® Super product;
- (b) the supply of equivalent or suitable alternate goods;
- (c) repairing the affected Sureform product; or
- (d) refunding the price paid by the claimant for the affected Sureform® Super product.

The benefit of this warranty is in addition to your rights under the Australian Consumer Law and to other rights and remedies of the consumer under a law in relation to the goods or services to which the warranty relates. That is, our goods come with guarantees that cannot be excluded under the Australian Consumer Law. You are entitled to a replacement or refund for a major failure and for compensation for any other reasonably foreseeable loss or damage. You are also entitled to have the goods repaired or replaced if the goods fail to be of acceptable quality and the failure does not amount to a major failure.
